



BACKGROUND



Causes of Rapid Spread in West Africa

- Urban characteristics, population mobility, cultural practices and resistance
- Home treatment of patients by health workers
- Inadequate infrastructure to support disaster preparedness
- Limited laboratory capacity, infrastructure & equipment
- Declining human capacity to mount robust response
- Coordination, communication and collaboration not defined
- Delay community engagement, mobilization & empowerment
- Lack of financial resources to support intervention(s)


- Restriction on movement (Cordon Sanitaire)
